- All Graduate and Doctoral programs within the College of Business (not including the EMBA, Global AMBA, or Mobile AMBA programs) are assessed an additional \$73.86 per credit hour Instructional Fee surcharge.
- All Graduate and Doctoral programs within the School of Nursing are assessed an additional \$10.00 per credit hour Instructional Fee surcharge.
